



STUDENT TERMS AND CONDITIONS

- For health and safety reasons, students are expected to attend classes dressed appropriately for movement.
- Students are expected to purchase Euphoria Dance and Therapy Ltd uniform after attending classes for one month.
- Students may be required to take part in performances and open classes. Prior notice will always be given by Euphoria Dance and Therapy Ltd.
- Euphoria Dance and Therapy Ltd. Do not accept responsibility for any damage to or loss of property whilst on the premises.
- A certain amount of risk is carried by any physical activity. Students taking part in any class at Euphoria Dance and Therapy Ltd. do so at their own risk.
- It is the responsibility of the parent/guardian to ensure that Euphoria Dance and Therapy Ltd. have the correct contact details and that these are updated in relation to any changes.
- Photographs and video footage containing students may be used for promotional purposes including use on Euphoria Dance and Therapy Ltd.'s website and social media pages.
- Euphoria Dance and Therapy Ltd. will not pass on any personal details to a third party unless it is in the student's interest. E.g., examination entry forms, competition entry forms. We will dispose of any paperwork containing personal details safely.

CLASS FEES & PAYMENTS

There are 3 options for payment of class fees.

Option 1: Monthly payments, these are to be paid on the 1st of each month via bank transfer only. Any pre booked holidays must be booked at least one month in advance with a maximum of 5 holidays (5 individual classes) throughout the calendar year.

Option 2: VIP 50. Set monthly payment of £50 per month allowing your child to take as many DANCE classes as they wish. This is a set payment and holidays cannot be deducted. A minimum of one month's notice is required to cancel VIP membership. This does not include Street Dance, Drama or Workshops.

Option 3: VIP 60. Set monthly payment of £60 allowing your child to take part in ANY dance/ drama class. This is a set payment and holidays cannot be deducted. A minimum of one month's notice is required to cancel VIP membership. This does not include workshops.

If payments are not made for the month, we cannot hold your child's place and will therefore have to wait to rejoin at our next intake. Payment must be made on the agreed date any late fees will incur a 10% charge. Please note, if payment is not made within a week of the agreed payment date (1st), the student will lose their place in the class. If the student would like to continue in the class after this time then they will be required to wait until the next intake.

UNIFORM

All students are expected to have the correct uniform for their class (Please see below) no later than one month from their start date. This uniform policy is in place to ensure the safety and inclusivity of all students. Uniform can be bought on the website or some secondhand uniform may be available at reception.

DREAM (Ages 4&5) – Minimum requirement of Euphoria T-shirt and black Jazz shoes. Students must wear leggings or joggers to be able to move safely.

BELIEVE (Ages 6&7) – Minimum requirement of Euphoria T-shirt with black leggings or joggers. Black Jazz shoes and a pair of latin shoes for each student.

ACHIEVE (Ages 8+) – Minimum requirement of Euphoria T-shirt and Euphoria leggings/ joggers. Black jazz shoes and a pair of latin shoes for each student.

INSPIRE (Invite Only) – Minimum requirement of Euphoria T-shirt, euphoria leggings/ joggers and Euphoria team jacket (black & white). Black jazz shoes and a pair of latin shoes for each student.

MUSICAL THEATRE – Minimum requirement of Euphoria T-shirt with black leggings or joggers. Black Jazz shoes.

PHYSICAL CORRECTION:

There may be occasion when teachers within Euphoria Dance and Therapy Ltd. may need to use physical intervention in respect of good teaching (adjusting arm position for example). It must be understood by parents/guardians that this is deemed necessary for effective teaching of dance technique. Any parent/guardian who is unhappy with this teaching technique should raise their concerns with Euphoria Dance and Therapy Ltd.

FIRST AID:

Lydia Dickinson is Euphoria Dance and Therapy Ltd.'s main First Aider. It is understood that first aid will be administered to students if deemed necessary. All accidents and injuries will be recorded in the accident records. Severe injuries will be reported to RIDDOR as appropriate. In the case of an emergency, and the parent/ guardian is not present, it is understood that Lydia Dickinson will act as 'loco parentis 'where necessary. Parents/guardians will be contacted as quickly as possible in the event of any injury/emergency. All our staff are fully First Aid trained.
